And to place, construct, operate, repair, maintain, patrol, relocate and replace thereon and to the extent Grantor is legally able to do so, upon all streets, roads or highways abutting said lands, a line or lines for the distribution or transmission of electric power, included but not limited to cable, wire, poles, transformers, concrete pads and such other equipment and appurtenances as may be desirable in connection therewith over/under or on the Right of Way, including subsequent extensions and tap extensions from the original lines or system. The Grantee has right to cut, treat and trim brush and shrubbery and to control by chemical means, to the extent necessary to keep clear of the said electric facilities and to cut down from time to time all dead, leaning or dangerous trees that are tall enough to strike the said electric system facilities in falling. To license and permit or otherwise agree to joint use occupancy of the line or system by any person, association or corporation for electrification, telephone and other communication purposes, except that said person, association or corporation shall first obtain their own right of easement from Grantor.

Grantor agrees to use all precautions not to disturb or destroy the overhead or underground electric distribution system facilities, notice signs, pad mounted transformers and related service equipment, nor to reduce the ground clearance which protects said facilities without express written consent of Grantee and to keep the easement area clear of trees, shrubbery, buildings and fire hazards. Grantor recognizes, in view of the narrow width of this easement, that occasionally Grantee's employees and equipment will operate outside this easement area in order to properly construct and maintain the service equipment located therein.

The undersigned agree that all poles, wires and other facilities installed on the above described lands at the Cooperative's expense shall remain the property of the Cooperative, removable at the option of the Cooperative.

It is further understood that, whenever necessary, words used in this instrument in the singular shall be construed to read in the plural and that words used in the masculine gender shall be construed to read in the feminine.
